Re:

Purchase of shares in Emperia Holding S.A. by investment company under the programme for buyback of shares in Emperia Holding S.A. by subsidiary P1 Sp. z o.o.

Update:

The Management Board of Emperia Holding S.A. ("Issuer") informs, that due to authorisation granted under Resolution 3 and 4 of the Extraordinary General Meeting of Shareholders of Emperia Holding S.A. of 11 October 2012 for the Meeting of the Company's Shareholders to approve the buyback by Emperia Holding S.A. and its subsidiaries of the Company's shares and to lay down the terms of the buyback and to approve conclusion of agreements between Emperia and its subsidiaries and Resolution 5/09/2013 of the Supervisory Board of Emperia Holding S.A. of 12 September 2013, during main market trading sessions on the Stock Exchange in Warsaw, Millennium Dom Maklerski S.A. ("Millennium") (investment company acting as an intermediary in the implementation of the programme for buyback of shares in Emperia Holding S.A. by P1 Sp. z o.o.) made purchase transactions for 15 280 shares in Emperia Holding S.A. of the nominal value of PLN 1.00 each in the period from 12 November 2013 to 15 November 2013. The Issuer's intention is to redeem the shares bought back. The average price of the shares bought back was PLN 69,62 per share. A detailed list of the share transactions is presented in an attachment to the report.

The 15 280 shares in the Issuer bought back account for 0,101% of the Issuer's share capital and carry the right to 15 280 votes at the General Meeting of the Issuer's Shareholders, which represents 0,101% of the total number of votes.

Pursuant to the terms of the agreement concluded between Millennium and P1 Sp. z o.o., the shares acquired by Millennium as part of the Issuer's buyback programme will be acquired by P1 Sp. z o.o. as part of a block trade, to be disclosed by the Issuer in a separate current report.

Upon completion of the trade with Millennium, the Issuer and its subsidiary, P1 Sp. z o.o., will hold in aggregate 1 212 093 shares in the Issuer, accounting for 8,019% of the Issuer's share capital and will carry the right to 1 212 093 votes at the General Meeting of the Issuer's Shareholders, representing 8,019% of the overall number of votes.
