Introduction to trading on GPW's main market shares in Emperia Holding S.A.

Update:

The Management Board of Emperia Holding S.A. (the "Issuer") has received information that the Management Board of the Warsaw Stock Exchange (Giełda Papierów Wartościowych w Warszawie S.A. – the "WSE") on 17 November 2016 passed a resolution regarding the admission and introduction to trading on GPW's main market of 1 978 ordinary bearer shares in Emperia Holding S.A., series P, with a nominal value of PLN 1 each.

The WSE's Management Board decided to introduce on 21 November 2016 Emperia Holding S.A.'s series P shares to trading on the main market, via regular procedure, on the condition that the National Depository for Securities (Krajowy Depozyt Papierów Wartościowych S.A. – the "KDPW") registers the shares on 21 November 2016 and assigns them the code PLELDRD00017.
