Re:

Implementation of the share buy back Programme.

Update:

As a result of the authorization granted by Resolution No. 21 Ordinary General Meeting of Emperia Holding SA (Company) dated 23 June 2010 and Resolution No 39/2010 of the Supervisory Board of Emperia Holding SA dated 16 September 2010 and in accordance with the provisions of the share buy back Programme Emperia Holding SA adopted by resolution of the Management Board of Company of 21 September 2010 (CR No. 44/2010), the Management Board of Emperia Holding SA inform, that on 05 November 2010 the Company acquired under the share buy back Programme in a block trade on the WSE 6 381 own shares with a nominal value 1.00 PLN each, in order for their further sale or redemption. The purchased shares of the Company provide 6 381 votes at the General Meeting of Shareholders Emperia Holding SA and constitute 0,042% of the share capital of the Company. The shares were acquired at a unit price of 98,50 PLN per share.

Since the implementation of the share buy back Programme, the Company acquired 75 141 shares provide 75 141 votes at the General Meeting of Shareholders Emperia Holding SA and constitutes 0,497% of the share capital.

The Company's shares were purchased from a brokerage house, to which on 21 September 2010 the Company signed a agreement on share buy back of Emperia Holding S.A.

Article 56(1)(2) of the Act on Public Offering, Conditions Governing the Introduction of Financial Instruments to Organised Trading, and Public Companies of 29 July 2005, in conjunction with § 5(1)(6) of the Regulation of the Minister of Finance of 19 February 2009 on current and periodical disclosures by issuers of securities and conditions for recognizing as equivalent disclosures required under regulations of a non-member state.
